

OFFICIAL RULES

Illinois Lottery “New Year, Massive Money” Sweepstakes and Powerball First Millionaire of the Year Promotion

1. SWEEPSTAKES PERIOD: The Illinois Lottery “New Year, Massive Money” Sweepstakes (“Sweepstakes”) begins 12:00 PM Central Time (“CT”) on September 7, 2021 and ends at 11:59 PM CT on October 15, 2021 (“Sweepstakes Period”).

2. SPONSOR AND ADMINISTRATOR:

For purposes of these Official Rules, “Illinois Lottery” shall mean the Illinois Department of the Lottery (“Department”), which is acting through Camelot Illinois LLC in its capacity as the private manager or its successor designated by the Illinois Lottery (“Sponsor”). The Sweepstakes is administered by PrizeLogic LLC (“Administrator”). The Department and Sponsor shall work with DCP Rights, LLC’s (“DCP”) and the Multi-State Lottery Association (“MUSL”) (DCP and MUSL shall collectively be, the “Prize Provider”) in fulfillment of the Powerball First Millionaire of the Year Promotion (“Promotion”).

3. AGREEMENT TO THE OFFICIAL RULES: By participating in the Sweepstakes, all entrants fully and unconditionally agree to and accept these Official Rules (including any and all rules and waivers related to or that specifically govern the Promotion) and the decisions of the Department, Sponsor, and Administrator as final and binding in all matters related to the Sweepstakes. Winning a prize (described below) is contingent upon fulfilling all requirements set forth herein.

4. HOW TO ENTER: To enter the Sweepstakes, entrants must visit www.ILNewYearMassiveMoney.com (“Sweepstakes Page”) and complete the online registration form in its entirety during the Sweepstakes Period. On the Sweepstakes Page, entrants must (a) confirm they are eighteen (18) years of age or older and a resident of the State of Illinois; (b) provide their first name, last name, mailing address, and email address and confirm acceptance of these Official Rules; and (c) provide the Sweepstakes code (“Code”) found in the ticket messaging of a Powerball® ticket purchased at an Illinois Lottery retailer during the Sweepstakes Period. During the Sweepstakes Period, entrants can enter a maximum of one (1) Code per day to receive one (1) entry into the Sweepstakes per day. After the initial entry, entrants will only be required to provide their email address and the Code. The Department, Sponsor, and Administrator are not responsible for entries that are incomplete or inaccurate. Limit one (1) Semi-Finalist prize per person.

The Sweepstakes computer, as determined in Administrator’s sole discretion, is the official timekeeping device for the Sweepstakes. The Department, Sponsor, and Administrator assume no responsibility for lost, mutilated, late, stolen, or misdirected entries in the Sweepstakes.

5. ODDS: Odds of winning the Semi-Finalist Prize, as defined and set forth in Section 7 of these Official Rules, depend on the total number of eligible entries received during the Sweepstakes Period. Odds of winning the Finalist Prize, as defined and set forth in Section 7 of

these Official Rules, depend on the number of lottery jurisdictions participating in the Promotion (“Participating Lotteries”). Odds of winning the \$1M Prize, as defined and set forth in Section 7 of these Official Rules, are 1 in 5.

6. ELIGIBILITY: The Sweepstakes is open only to individuals who, at the time of entry, are at least eighteen (18) years of age and are residents of the State of Illinois. In addition, the following persons are not eligible to enter this Sweepstakes, participate in the Promotion, or claim any prize related thereto: (a) the employees, officers, directors, partners, equity holders, members, contractors, and agents of Administrator, DCP, MUSL, American Broadcasting Companies, Inc. (“ABC”), and/or any of their respective parent, subsidiary, and/or affiliated entities; (b) any member of the Lottery Control Board (“Board”) and any officer or any other person employed by Sponsor, the Board, or the Department; (c) owners, officers, and employees of the Sponsor (d) officers and employees of advertising, public relations, and sales promotion agencies employed by the Department who are directly involved in the Department’s engagement; (e) officers and employees of audit firms performing services for the Department; (f) other contractors and agents of the Department; and (g) any spouse, child, or family member residing as a member of the same households in the principal place of residence of any person designated in (a) through (f). This Sweepstakes and Promotion are void where prohibited by law.

7. PRIZES AND THE VALUE OF THE PRIZES:

Fifty (50) Semi-Finalist Prizes: Each Semi-Finalist Prize Winner (as defined below) will receive \$500 and one (1) entry into a drawing for a chance to win a Finalist Prize (collectively, the “Semi-Finalist Prize”). The approximate retail value (“ARV”) of the Semi-Finalist Prize is \$500.

Five (5) Finalist Prizes: Each Finalist Prize Winner (as defined below) will receive \$10,000; a surf and turf dinner for eight (8) people from Omaha Steaks; 70" LED television; home theater sound system with installation; 15.5" laptop computer; 20 mega-pixel digital camera; on-camera microphone; 19" ring light; laptop stand and home set-up; \$500 gift certificate to Party City; \$500 beverage package from a local retailer; karaoke system; two (2) gift bags with contents to be determined at a later date, each with an ARV of \$250; and one (1) entry in the Promotion drawing for a chance to win the \$1M Prize (as defined below) (collectively, the “Finalist Prize”). The ARV of the Finalist Prize is \$20,000.

One (1) \$1M Prize: The \$1M Prize winner will receive \$1,000,000 (“\$1M Prize”). The ARV of the \$1M Prize is \$1,000,000.

The Semi-Finalist Prize, the Finalist Prize, and the \$1M Prize, if and as applicable, may be referred to herein as a “Prize(s).” The Semi-Finalist Prize Winner, the Finalist Prize Winner, and the \$1M Prize Winner, if and as applicable, may be referred to herein as “Winner(s).”

The dates and times of the Sweepstakes and Promotion may be subject to change and cancellation. Winner(s) and any guest(s), if and as applicable, agree to comply with all applicable venue rules and policies in connection with any Prize(s). Any comments made by a Winner in a social media format containing material that is inappropriate, offensive, indecent, obscene, hateful, tortious,

defamatory, slanderous, or libelous may disqualify the Winner, at the sole discretion of Sponsor, Administrator, and/or Prize Provider, as applicable. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppage, or any other natural disaster outside their control that may cause the cancellation or postponement of the Sweepstakes and Promotion and/or the fulfillment of any Prize(s). All other expenses and costs, not expressly listed above, including, but not limited to, federal, state, and local taxes, parking, and ground transportation, are each Winner's sole responsibility. The Released Parties will not be responsible for any loss, liability, or damage arising out of a Winner's acceptance or use of a Prize or any element thereof. The Prizes are not exchangeable or otherwise transferable.

8. WINNER SELECTION AND NOTIFICATION TO PRIZE WINNERS:

For all of the Prizes set forth below, potential Winners will be contacted and receive instructions on how to claim the applicable Prize as set forth herein ("Prize Notification"). The Prize Notification will be sent to the email address the potential Winner provided when entering the Sweepstakes. The potential Winners will be required to execute and return the Sweepstakes prize claim form (either in person or via email) and/or such other releases, forms, and documents as Sponsor and/or Prize Provider may require, unless prohibited by law. For the Semi-Finalist Prize, the potential Semi-Finalist Prize Winner(s) will have the length of time specified by Sponsor in the Sweepstakes prize claim form. If applicable, for the Finalist Prize, the Finalist Prize Winner will have the amount of time specified by Prize Provider to accept the Finalist Prize. By entering, the entrant consents to be contacted by the Department, Administrator, DCP, and/or its respective designee in connection with the applicable Prize Notification. The Department, Sponsor, Administrator, and Prize Provider will not be liable for any delays in the receipt of Prize Notification messages. All potential Winners are subject to verification of identity and eligibility prior to the award of any Prize.

Semi-Finalist Prize Winners: Administrator will conduct a drawing to randomly select fifty (50) Semi-Finalist Prize Winners from the pool of eligible Sweepstakes entries. Administrator will provide Prize Notification to the potential Winners on or around October 18, 2021. Administrator will send the cash portion of the Semi-Finalist Prizes to the winners via Chase QuickPay.

If any potential Semi-Finalist Prize Winner does not respond to the Prize Notification from the Department or Administrator within the time period set forth in the Sweepstakes prize claim form or declines the Semi-Finalist Prize for any reason, disqualification and Semi-Finalist Prize forfeiture will result, and at Sponsor's or Administrator's sole discretion and time permitting, an alternate potential Semi-Finalist Prize Winner will be randomly selected from the pool of eligible entries received during the Sweepstakes Period.

Finalist Prize Winners: MUSL will conduct a drawing on or about November 4, 2021, to randomly select five (5) Finalist Prize Winners from the pool of eligible entrants submitted by all Participating Lotteries, including all Semi-Finalist Prize Winners. If a potential Finalist Prize Winner is one of the Semi-Finalist Prize Winners ("IL Finalist Prize Winner"), the Department or its designee and DCP will provide Prize Notification to the potential IL Finalist Prize Winner on or around November 10, 2021. The Department shall determine if any potential IL Finalist Prize Winners have an outstanding debt to the State of Illinois or any city or county within Illinois, owe delinquent taxes, or are past due on child support. If any such debt is discovered, it

will be offset from the \$10,000 portion of the Finalist Prize. For IL Finalist Prize Winners, the Department will fulfill the \$10,000 portion of the Finalist Prize, and DCP will be responsible for fulfillment of the remainder of the Finalist Prize.

If a potential Finalist Prize Winner does not respond to the Prize Notification from DCP (or its designee) within the time period specified by DCP, forfeits, or declines the Finalist Prize for any reason, disqualification and Finalist Prize forfeiture will result, and at Prize Provider's sole discretion and time permitting, an alternate potential Finalist Prize Winner will be randomly selected by MUSL from the pool of eligible entrants submitted by the Participating Lotteries or from a list of alternates drawn at the time of the initial Finalist Prize drawing, as MUSL may determine in its sole discretion.

\$1M Prize Winner. The \$1M Prize Winner will be randomly selected by MUSL from the eligible Finalist Prize Winners in a drawing that will take place during the broadcast of the live television special titled *Dick Clark's New Year's Rockin' Eve* (2021-22) ("Program") on December 31, 2021. If the potential \$1M Prize Winner is an IL Finalist Prize Winner ("IL \$1M Prize Winner"), the Department shall determine if the potential IL \$1M Prize Winner has an outstanding debt to the State of Illinois or any city or county within Illinois, owe delinquent taxes, or are past due on child support. If any such debt is discovered, it will be offset from the \$1M Prize. If there is an IL \$1M Prize Winner, the Department will provide the \$1M Prize.

9. GENERAL PRIZE RESTRICTIONS: Prizes are subject to availability and change. Only one (1) Semi-Finalist Prize Winner per household will be allowed during the Sweepstakes Period. If due to a printing, production, or other error, more Semi-Finalist Prizes are claimed than are intended to be awarded, the intended Semi-Finalist Prizes will be awarded in a random drawing from among all verified and validated entries in the Sweepstakes. All Semi-Finalist Prizes won by Semi-Finalist Prize Winners will be subject to the Department's debt setoff procedures. No substitution or cash redemption allowed by Semi-Finalist Winners. The Department, Sponsor, and Administrator reserve the right to substitute the Semi-finalist Prize in whole or in part with other prizes of comparable or greater value, if the intended Semi-Finalist Prize is not available for any reason, as determined by the Department, Sponsor, and Administrator, in their sole discretion. The Semi-Finalist Prize Winners will be exclusively and solely responsible all other costs and expenses associated with prize acceptance and use not described as being provided. This Sweepstakes and Promotion are governed by and shall be construed in accordance with Illinois law and is subject to all applicable federal, state, and local laws and regulations. Any and all taxes, including, but not limited to, federal, state, and local taxes, are the exclusive and sole responsibility of the Winner. The Winner may be required to provide his or her Social Security number and appropriate tax documentation for tax reporting purposes. If required, the Department or its designee will file an IRS Form 1099 or similar document with the Internal Revenue Service for the fair market value of any Prize.

10. FINALIST PRIZE TERMS AND CONDITIONS:

Finalist Prize Winners must agree to (i) participate and appear on the Program via remote video transmission from his/her residence or another local location to be determined by DCP in its sole discretion, subject to executing an appearance release, clearing a background check, and complying with all then-current federal, state, and/or local government and/or agency, ABC, or

DCP laws, regulations, restrictions, guidelines, and/or protocols (collectively, “Production Requirements”); OR (ii) appoint a proxy (or have a proxy appointed) to participate and appear on the Program via remote video transmission from the Finalist Prize Winner’s residence or another local location to be determined by DCP, subject to the proxy’s satisfying the Production Requirements. With the exception of the Prize Notification response, Finalist Prize Winners must execute and return all required documentation within five (5) days of receipt (or such shorter period as DCP’s production exigencies may require). Failure to respond and/or execute and return such documentation by the specified deadline(s) may result in forfeiture of the Prize. If the Finalist Prize Winner elects to appoint a proxy, he/she must do so no later than November 19, 2021.

In the event that the Finalist Prize Winner’s selection for a proxy does not satisfy the Production Requirements, DCP reserves the right, in its sole discretion, either to (i) allow the Finalist Prize Winner to appoint another proxy to appear in the Program in the Finalist Prize Winner’s place (subject to DCP’s production schedule and deadlines and satisfying the Production Requirements); or (ii) select and appoint another proxy to appear on the Program in Finalist Prize Winner’s place. Notwithstanding the foregoing, DCP reserves the right to appoint a proxy to appear and participate in the Program for the Finalist Prize Winner for any reason as it may determine in its sole discretion. The appointment of any proxy shall not affect the Finalist Prize Winner’s eligibility for the \$1M Prize or receipt of the Finalist Prize.

For the avoidance of doubt, the Finalist Prize Winner’s eligibility to participate in the Program and/or the drawing for the \$1M Prize is not affected by the Finalist Prize Winner’s failure to satisfy the Production Requirements and/or by any information obtained pursuant to a background check, but those failures may affect the nature of Finalist Prize Winner’s appearance and/or degree of participation in the Program. While the Finalist Prize Winner’s eligibility to participate in the \$1M Prize drawing is an element of the Finalist Prize, the opportunity to participate in the recording and production of the Program and/or appear in the broadcast of the Program is expressly not an element of the Finalist Prize and is determined by DCP in its sole discretion.

The Finalist Prize Winner agrees to provide DCP (or its designees) with reasonable access to his/her residence, subject to DCP’s approval and Production Requirements, for the production and broadcast of the Program, both prior to and on December 31, 2021, to participate in rehearsal(s) on or about December 30, 2021, if required, and to execute (or facilitate the execution of) a customary location agreement, if and as required by DCP. DCP reserves the right to arrange (at its sole cost and expense) filming at another location within one hundred (100) miles of Finalist Prize Winner’s residence where the Finalist Prize Winner (or his/her proxy), household members, and subject to the Production Requirements, a DCP-designated number of guests may participate and appear in the production and broadcast of the Program (“NYE Party”). In such event, DCP will provide the location, transportation, food, beverage, and other production elements for the NYE Party in addition to the Finalist Prize. Finalist Prize Winner’s household members and if applicable, guests celebrating with the Finalist Prize Winner on December 31, 2021, whether at the Finalist Prize Winner’s residence or NYE Party, will be required to satisfy DCP’s Production Requirements. In connection with filming, whether at the Finalist Prize Winner’s residence or the NYE Party, the Finalist Prize Winner and his or her household members and guests must comply with all applicable federal, state, and local government and/or agency laws, rules, orders, and

regulations as well as DCP's rules, regulations, and/or safety guidelines and if applicable, the rules and regulations of the venue where the NYE Party may be held.

Prize Provider shall determine, in its sole discretion, the specific merchandise models, items, vendors, and/or retailers for all elements of the Finalist Prize and reserves the right to substitute (i) any portion or elements of the Finalist Prize for a prize of comparable or greater value; and/or (ii) any specified brand, vendor, or retailer for one of comparable quality. Elements of the Finalist Prize are subject to availability, may vary based on Finalist Prize Winner's location, and may be fulfilled by third-party companies and/or vendors. All other costs and expenses related to acceptance and use of any element of the Prize not specified herein as being provided are the sole responsibility of Winner, including, without limitation, any fees, costs, and/or taxes for broadcast, cable, and/or satellite television, broadband, internet, and/or wireless services and/or access.

Except as set forth above or otherwise in Prize Provider's sole discretion, no exchanges, substitution, cash redemption, assignment, or transfer of the Finalist Prize or any elements thereof is permitted. Any rejected, unused, and/or undeliverable elements of the Finalist Prize will be forfeited, will not be redeemable for cash, and may not reduce the value of the Finalist Prize for tax purposes.

All gift cards, stored-value cards or certificates, store cards, merchant cards, vouchers for services or goods, and gift certificates or similar instruments that are included in and provided as part of the Finalist Prize ("Gift Cards") and the redemption thereof are subject to terms, conditions, and restrictions, including any expiration dates, set by the merchant or issuer of the applicable Gift Cards. See each Gift Card for applicable terms, conditions, and restrictions. Gift Cards are not redeemable for cash or exchangeable for any other prize. Except as required by law, the Gift Cards cannot be reloaded, resold, transferred for value, redeemed for cash, or applied to any other account. The Department, Sponsor, Administrator, and Prize Provider are not responsible for any Gift Cards that are lost, stolen, destroyed, or used without permission, and any Gift Cards that are lost, stolen, destroyed, or used without permission will not be replaced.

Failure to respond and/or execute and return required releases and other documentation and/or failure to collect, properly claim, respond, and/or cooperate in the acceptance, receipt, delivery, and/or fulfillment (including any installation) of any element of the Finalist Prize may result in forfeiture of the Finalist Prize or the applicable element thereof, as Prize Provider may determine in its sole discretion. If forfeited for any reason, Finalist Prize Winner will not receive any other prize substitution or compensation of any kind, and Prize Provider may award the Finalist Prize to an alternate recipient as it may determine in its sole discretion.

THE RELEASED PARTIES (DEFINED BELOW) ARE NOT RESPONSIBLE OR LIABLE, IN ANY WAY, FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF ANY ACCEPTANCE, FULFILLMENT (INCLUDING SHIPPING AND HANDLING), INSTALLATION, OPERATION, LOSS, USE, OR MISUSE OF THE PRIZES AND/OR ANY ELEMENT THEREOF. THE RELEASED PARTIES DO NOT MAKE, AND ARE NOT RESPONSIBLE IN ANY MANNER FOR, ANY WARRANTIES, REPRESENTATIONS, OR GUARANTEES OF ANY KIND, EXPRESS OR IMPLIED, IN FACT OR LAW, RELATING TO ANY ELEMENTS OF THE PRIZES, REGARDING THE USE, VALUE, OR ENJOYMENT

OF ANY ELEMENTS OF THE PRIZES, INCLUDING, WITHOUT LIMITATION, ITS QUALITY, MECHANICAL CONDITION, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE, AND ALL SUCH WARRANTIES ARE HEREBY DISCLAIMED.

11. GENERAL CONDITIONS AND RELEASE: The Sweepstakes and Promotion are subject to applicable laws and regulations. By entering, each entrant (a) agrees to defend, indemnify, release, and hold harmless the Department, Sponsor, the Administrator, and Prize Provider, and each of their respective owners, parents, affiliates, subsidiaries, directors, officers, agents, employees, managers, licensees, distributors, dealers, retailers, printers, representatives, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes and Promotion, and all of their respective officers, directors, employees, agents, and representatives (collectively, the "Released Parties") from and against any and all claims, causes, costs, injuries, losses, or damages of any kind that may occur, directly or indirectly, in whole or in part, arising out of the entrant's participation in this Sweepstakes, Promotion, or receipt or use of any Prizes, including, but not limited to: (i) unauthorized human intervention in the Sweepstakes or Promotion; (ii) technical errors related to computers, servers, providers, or telephone or network lines; (iii) printing errors; (iv) lost, late, postage-due, misdirected, or undeliverable mail; (v) errors in the administration of the Sweepstakes, Promotion, or the processing of entries, including, but not limited to, data entry errors resulting from or caused by the entering, keying, or mis-keying of the required information by entrants; (vi) injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes, Promotion, or receipt or use of any Prize; (vii) the unauthorized or illegal access to personally identifiable or sensitive information or the acceptance, possession, use, or misuse of any Prize or any travel or activity related to the receipt or use of any Prize; (b) gives his/her express permission to be contacted by the Department, Sponsor, Administrator, DCP, and each of their respective designees by telephone, email, and/or postal mail for Sweepstakes or Promotion purposes; (c) if selected as a Winner, consents to the use by Department, Sponsor, Administrator, Prize Provider, and each of their respective designees of the Winner's name, hometown, photograph, voice, or other likenesses and Prize information for promotion, advertising, and marketing purposes in any media or format, now known or hereafter devised, throughout the world, in perpetuity, without additional compensation, consideration, notification, or permission, unless prohibited by law, and upon request will provide written confirmation of such consent; and (d) acknowledges that none of the Released Parties or anyone else has either made, or is in any manner responsible or liable for, any warranty, representation, or guarantee, either expressed or implied, in fact or in law, relative to any Prize, including, but not limited to, its quality or availability and ALL SUCH WARRANTIES ARE DISCLAIMED IN THEIR ENTIRETY.

None of the Released Parties or any of their service providers are responsible for incorrect or inaccurate transcription of entry information; any human or other error, technical malfunctions; lost or delayed data or voice transmission; omission; interruption; deletion; defect; line failures of any telephone network, computer equipment, or software; inability to access any online service or website or to complete a telephone call or facsimile transaction; any other error or malfunction; late, lost, or misdirected mail; or any injury or damage to an entrant's or any other person's computer related to or resulting from participation in this Sweepstakes or the Promotion.

None of the Released Parties are responsible for or liable for: (a) late, lost, damaged, misdirected,

misaddressed, incomplete, unintelligible, illegible, or postage due entries; (b) telephone, electronic, hardware or software program, network, internet or computer malfunctions, failures or difficulties of any kind; (c) failed, incomplete, garbled, or delayed computer transmissions; (d) any condition caused by events beyond their control that may cause the Sweepstakes or Promotion to be disrupted or corrupted; (e) any injuries, losses, or damages of any kind arising in connection with or as a result of the Sweepstakes or Promotion, acceptance, possession, or from participation in the Sweepstakes or Promotion; (f) any printing or typographical error in any material associated with the Sweepstakes or Promotion; (g) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, wireless service, mail, typographical, printing or otherwise relating to or in connection with the Sweepstakes or Promotion, including, without limitation, errors or difficulties that may occur in connection with the administration of the Sweepstakes or Promotion, the processing of entries, the announcement of the prizes, or in any Sweepstakes- or Promotion-related materials; or (h) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes or Promotion.

The Department, Sponsor, and the Administrator reserve the right, in their sole discretion, to cancel the Sweepstakes in its entirety if it becomes technically corrupted or because of non-authorized human intervention. The Department, Sponsor, and Prize Provider reserve the right, in their sole discretion, to cancel the Promotion in its entirety in the event of an occurrence beyond its reasonable control. If any discrepancy should exist between these Official Rules and any promotional material describing this Sweepstakes or Promotion, these Official Rules shall govern.

DISPUTE RESOLUTION: Except where prohibited by law, by entering, Sweepstakes entrants agree that in the event of a dispute concerning the construction, validity, interpretation, or enforceability of these Official Rules, the determination of the Department shall be final and binding. Any entrant who disputes a final decision of the Department may seek review before a hearing officer pursuant to Section 7.3 of the Illinois Lottery Law. Code Part 1700), the Director will review the recommendation of the hearing officer and, if applicable, the Board, and issue a final decision regarding the dispute. Any party adversely affected by a final decision or order of the Director may obtain judicial review as provided by the Illinois Lottery's hearing rules and Administrative Review Law (735 ILCS 5/Article III). All issues and questions concerning the rights and obligations of participant(s) in relation to the Department, Sponsor, Administrator, and their agents shall be governed by and construed exclusively in accordance with the laws of the State of Illinois without giving effect to any principles of conflicts of law of any jurisdiction. Entrant agrees that any such action at law or in equity shall be filed only in the state or federal courts located in Chicago, Illinois, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such action.
